- Sewers I have seen enough information to say that I am firmly against this current plan for sewers. Our own sewer committee did an outstanding job of analyzing the information and showed that this initiative is based on unsubstantiated claims about the health of the lake and a financial approach that would devastate our community. Our Board should be representing its constituents by clearly explaining the process for our formally opposing this and what legal rights we have. If a vote is needed then let's have it. Action needs to be taken immediately.
- Gates this has been discussed for a long time but it's not clear that this has really been analyzed, and the information has not been presented to the community so a decision can be made.
- More detailed minutes for Board meetings should be produced (and shared soon after each meeting) that allow the reader to actually understand what was discussed and the reasons for a decision, and not just the topic that was discussed.
- I also support providing these notes on a technology platform that can be easily searched by all. Credit for this suggestion goes to a neighbor I spoke with last weekend and there are good tools readily available for this.
- All meetings of the Board should be accessible remotely by Microsoft Teams or a
  voice only dial-in. This is how business is done today across the world, and good
  tools are readily available. Participation at all levels should not be limited to those
  that are able to attend in person, and we will be a better community if we are
  inclusive of all who want to be involved.
- We should also not let the pursuit of a perfect solution prevent us from using a good solution. Remote access to meetings is just one example of this. Over 6 months ago I proposed that we purchase a Polycom speakerphone for a few hundred dollars to support remote access for meetings. I also explained then that Microsoft Teams on a laptop would not do as much as a Polycom could to address sound quality. If we want to encourage members of the community to participate then we need to make it easy for them to do so, and take into consideration their commitments to be at home with kids in the evening, travel for work, etc.
